
Merry Christmas and Happy Holidays!

Chartering

Mu Chapter at The Ohio State University

After fraternity leadership approved the chartering of Mu Colony at the 2018 National Conclave, colony members were officially re-chartered as Mu Chapter at The Ohio State University on October 19th, 2018.

Executive Director Jeremy Slivinski, National President Rich Cruz, and AKL staff traveled to Columbus, Ohio to initiate and assist 32 men in signing the charter into action.



When asked about the road from colony to chapter, Chapter President Kyle Weddington said “Difficult would be an understatement. Founding a colony and then learning how to run and maintain it efficiently is no easy task. What to Pack

- Attire is business casual for the entire duration of the event. (minimum, slacks /khakis, button-down shirt). Jeans, gym-shorts and t-shirts are not appropriate during any scheduled programming

Winter Break Checklist

Preparing chapter facilities for a safe winter break

It's time to make sure that Greek undergraduate leaders, chapter advisors and alumni take the time to ready their chapter facilities for the colder months and winter break. This Winter Break Checklist was developed by our insurance partners at Holmes Murphy as a risk management tool to assist chapters in preparing for the coming break period.

Inside Chapter Facility

- Ensure furnace is on and thermostat is set at or above 60 degrees.
- In extreme cold weather, open the indoor faucets slightly to allow water to trickle, as moving water does not freeze as easily.
 - Watch to ensure no backup in drains.
- Leave the doors to cabinets that contain water lines open, this will allow heat to enter the area.
- Ensure all non-essential appliances and electronics have been unplugged.
- Secure Chapter house and lock all valuables.
- Contact the local police department or campus security to check on the chapter house periodically.
- Thoroughly clean Chapter house prior to extended break.
- Confirm that heat registers are not blocked and combustible materials are safely stored.
- Remove all perishable food.
- Inspect all rooms and check for the following:
 - Unnecessary damage. Any damage discovered should be documented.
 - Unplug all nonessential appliances and electrical devices.
 - Ensure heat registers are not blocked by personal belongings.
 - Lock room/suite door for security.



Provide Chapter Facility Caretaker With:

- A Master Key
- Alumni House Corporation Contact
- Emergency Response Contact & Emergency Repair Company options
- Insurance Claim Reporting Information

Outside Chapter Facility

- Lock and inspect all windows and repair all broken glass.
- Ensure that exterior doors are well insulated and close and latch completely.
- Inspect hot water heater and exposed water lines & drain pipes for slow leaks.
- Attach and secure downspouts with extension from foundation to prevent water damage.
 - Ensure they fully displace water away from foundation and other walking areas without draining onto the driveway, sidewalks, or patios.
- Ensure all hoses are removed from exterior water spigots/faucets.
- Clean gutters and downspouts to ensure proper roof drainage.
 - Improper roof drainage can cause ice damming to occur, which can cause interior water damage.
- Drain water lines in lawn sprinkler system where appropriate
- Clean exterior of chapter house, removing yard debris or materials that could be used to start a fire, as well as any items stored next to the chapter house.
 - Debris can provide an opportunity for an arsonist.
- Check security/safety lighting.
- Service and clean fireplace and chimney and check for defects or debris.

Remembering

Rev Dr. James Gordon Emerson Jr.

James "Jim" Emerson passed away September 12th, 2018 due to pancreatic cancer at the age of 92. Jim was born in Palo Alto, California in 1926. He became a brother of Alpha Kappa Lambda fraternity at the Beta Chapter during his undergraduate years at Stanford University. Graduating in 1946, Jim continued his education at Princeton Seminary and the University of Chicago.



After becoming an ordained Reverend, he would serve as national Chaplain for the fraternity for many years. During his time as National Chaplain, Jim wrote the Invocation and Benediction still used by chapters today. After his time as Chaplain, Jim served as Alpha Kappa Lambda's National President from 1979 through 1981.

Beyond volunteering for the fraternity at the national level, he was also Director of the Community Service Society of New York City, was a pastor at Calvary Presbyterian Church in San Francisco, and he helped form a group

of prominent religious figures that took on the task of helping homeless people in California. Later in life, he served as Interim President of the San Francisco Theological Seminary.

Jim's memory lives on, and is survived by his three children, eight grandchildren, and two great grandchildren. He was a hard working and dedicated brother of Alpha Kappa Lambda. His truth and his word will live on as he passes over to the Omega chapter.

Stand up to Harvard

On December 3, 2018, sororities, fraternities, and students filed lawsuits in federal and Massachusetts courts challenging the Harvard sanction policy that punishes students who join off-campus, single-sex social organizations. In the federal suit, a broad coalition of students and women's and men's organizations impacted by Harvard's sanctions assert that through the sanctions policy, the President and Fellows of Harvard College have interfered with students' right to be free of sex discrimination, as guaranteed by Title IX and the U.S. Constitution.

In the suit filed in Massachusetts court, three women's organizations assert that Harvard has interfered with student's rights to free association and equal treatment based on sex, both of which are protected by the Massachusetts Constitution.

Alleging violations of the Massachusetts Civil Rights Act, the suit seeks to stop Harvard's sanctions by calling for an injunction prohibiting the University from continuing to unlawfully punish students.

"As a result of this policy, almost all of the once vibrant sororities and women's final clubs open to Harvard women have either closed or had to renounce their proud status as women's social organizations," said Renee Zainer, International President of Alpha Phi, a plaintiff organization in the state case. "Together, we are standing up to Harvard on behalf of all students, because they have the right to shape their own leadership and social paths. Harvard simply can't erase the spaces students value for support and opportunity."

Title IX has long recognized the important role single-sex organizations can play in student development, which is why it includes special protections for fraternities and sororities. Yet Harvard's sanctions policy discriminates on the basis of sex and restricts the sex of people

with whom students may associate, dictating punishments based on gender stereotypes. "Harvard's sanctions policy discriminates on the basis of sex and punishes students because they associate with people of their own sex," said Emma Quinn-Judge of Zalkind Duncan & Bernstein LLP, a lawyer for the plaintiffs in the Massachusetts case.

"Sororities, fraternities and students sued Harvard today because its sanctions policy is discriminatory and unlawful," said R. Stanton Jones of Arnold & Porter, a lawyer for the plaintiffs in the federal case. "The disregard of students' basic freedoms and the destruction of the women's groups is indefensible. Harvard should get out of the business of trying to dictate who students spend their time with off campus."

Both complaints recount Harvard's campaign of threats and coercion in unveiling and implementing the sanctions policy and document the particular devastation the policy has wrought on all-women's social organizations despite their proven value. Harvard undergraduates have been deterred from joining sororities, and their private, off-campus spaces sit empty.

The plaintiffs and lawsuits have a breadth of support from nearly 100 single-sex organizations, including the 26 sororities of the National Panhellenic Conference (NPC), the 66 fraternities of the North American Interfraternity Conference (NIC), and the organizations in the Cambridge Coalition.

"It is baffling that Harvard boasts that its students are among the brightest minds in the world, yet administrators won't trust them to make decisions about how they choose to associate with one another," said Judson Horras, the President and CEO of the North American Interfraternity Conference. "Harvard ignores the proven value of single-sex experiences, despite the fact that Drew Faust, the Harvard President who put the sanctions into place, benefited from attending an all-women's academy and college, and current President Lawrence Bacow has publicly praised the value of his own fraternity experience."
